

2010 Grants

The foundation has significantly increased its rate of giving during the economic downturn and recovery period, in response to the increased demand for children's services at a time of budget cuts and decreased revenues.

In 2010, the foundation awarded cash grants of over \$450,000 for program support, and a variety of other types of support including capacity building and infrastructure support, long and short term fundraising challenge grants, and organizational effectiveness grants.* Additionally, the foundation provided over 400 hours of direct non-financial support services to our partners, in the areas of communications (website, media, press, online, video, webinar), collaborative project planning, identifying and implementing strategic partnerships, and related assistance.
